Letters and papers of a St. Louis lawyer and delegate from the 25th Senatorial District. Convention work, especially the Committee on Local Government (City of St. Louis, St. Louis County, and Jackson County) which he chaired. He also served on Committees on Military Affairs; Miscellaneous Provisions; and Information, Submission and Address to the People.

The papers were donated to the University of Missouri by A. Evan Hughes on 26 October 1944 (Accession No. 165).

## BIOGRAPHICAL SKETCH

A. Evan Hughes was born in St. Louis, Missouri, on October 12, 1893. He was graduated from the Benton Law School, St. Louis, in 1915 and established a law practice. In 1920, he was appointed executive secretary and attorney for the St. Louis Real Estate Exchange, and from 1933 to 1938 he served as probate judge of St. Louis County. He also served as a member of the commission which drafted the 1950 St. Louis County charter. Hughes died in St. Louis on 6 August 1951.
