#### INTRODUCTION

The "As I Recall" Oral History Project records contain audio recordings and some transcripts from a collaborative project between KBIA-FM and the State Historical Society of Missouri. Most oral histories in this collection were conducted by Gary Kremer, Director of the State Historical Society, in 2006.

#### DONOR

The "As I Recall" Oral History Project is an artificial collection representing a collaboration between *The State Historical Society of Missouri*, the Western Historical Manuscript Collection, and the Columbia National Public Radio Station, KBIA. The "As I Recall" project was based upon oral histories housed at the Society and WHMC. In addition to using the oral histories housed in other collections, new oral histories were collected by the director of the State Historical Society of Missouri, Dr. Gary R. Kremer in 2006 (Accession No. CA6265).

#### SCOPE AND CONTENT NOTE

The records of the "As I Recall" Oral History Project consist of oral history interviews on cassette tapes and corresponding patron use CDs, some transcripts, and digital photographs of some of the interviewees. CDs contain the same content as the interviews on cassette.
