*Administrative records including minutes, correspondence, transportation files, membership, public relations, legal files, reports, "The Grain Market Review" and associated materials from the Kansas City Board of Trade.*

### HISTORY:

In 1856, a "Board of Trade" was organized in Kansas City, Missouri, to promote the commercial interests of the city. It operated informally in advancing Kansas City's commerce until 1873, when it received its charter. In 1876, it filed articles of incorporation under the name Board of Trade of Kansas City, Missouri, Inc. The name has been retained except for the period from 1889-1896, when it was called the "Commercial Exchange." The function of the Board evolved from generally promoting commerce and transportation in the region to providing an organization for the trading of grain and other agricultural commodities.

### PROVENANCE:
