Speeches, writings, correspondence, photographs, and personal files of Oliver, Senior U.S. District Judge of Western Missouri. Also personal papers of his wife, Gertrude Field Oliver (1916-).

BIOGRAPHY:

Senior U.S. District Judge John W. Oliver was appointed a Federal judge by John F. Kennedy in 1962. A native of Cape Girardeau, Missouri, Oliver graduated from the University of Missouri School Of Law. He moved to Kansas City where he practiced with McCune Caldwell Downing, and its successor firms from 1936 until 1962. In 1940, Oliver married Gertrude Field of Kansas City, Missouri. They had four children: John Oliver, David Oliver, Trudy Oliver Bulkley, and Zimra Oliver Korp.

John W. Oliver was a member of the Penn Valley Meeting (Kansas City, Missouri) Society of Friends (Quakers). He served as Democratic member of Jackson County Charter Commission in 1948-1949, as Chairman and Democratic member of the Board of Election Commissioners of K.C., MO from 1950-1954, and President and member of Missouri State Board of Law Examiners from 1954-1962. Since being a member of the federal judiciary, he served on; the Committee on the Administration of Probation Service of the United States Judicial Conference, the faculty of numerous Sentencing Institutes for Federal Judges, and the faculty for newly Appointed Federal Judges. Judge Oliver served as Chief Judge of the United States District Court from February 8, 1977, until he took senior status on November 3, 1980. He also served as President of the District Judges Association for the Eighth Circuit and Chairman of the ABA National Conference of Federal Trial Judges.

The University of Missouri awarded Judge Oliver its Citation of Merit in December of 1963, and it's Faculty-Alumni Award in 1972.
