These are school records from two rural school districts in Bollinger County, Missouri. In volumes prescribed by the state, local officials entered minutes of meetings, school censuses, and other data in specified categories.

The first volume, apparently from the "Ladd" area, covers District No. 4 during the years 1889 to 1896. There is also a small amount of data for District No. 78 for 1917-1918.

The second volume, apparently from the "Hamstring" area, covers District No. 35 during the years 1913 to 1929.

### Shelf List

These are school records from two rural school districts in Bollinger County, Missouri. In volumes prescribed by the state, local officials entered minutes of meetings, school censuses, and other data in specified categories.

**Volume I:** "Records of School District No. 4, Township No. 29, Range No. 9 & 10, County of Bollinger, State of Missouri."

"Record of Annual School Meetings," 1890-1895, 1917-1918. All eligible voters in the district would meet annually to elect directors, set tax rates, and make policy decisions. The records for 1917-1918 are for "Ladd District No. 78" but it seems to include the same geographical area as district No. 4.

"Directors' Proceedings," 1889-1896. Minutes of meetings of the Board of Directors of the district.

"Record of Special School Meetings," 1894.

"Estimate Returned," 1890-1894. This is an "estimate of amount of funds necessary to sustain the public school, the amount on hand, and the amount to be levied."

"Annual Enumeration," ca. 1890-1895. The school census.

"List of Tax Payers," ca. 1890-1895.

"District Funds," 1890-1894.

"Register of Orders," 1889-1896. Chronological list of disbursements.

"School Treasurer. In Account with this District," 1889-1895. Treasurer's summations and balances.

"Register of Teachers," 1889-1895.

"Teacher's Contracts," 1890-1895.

"Teachers' Term Report," 1890-1896. Annual report on length of school term, enrollment, and attendance.

"Rules and Regulations Adopted," 1892-1893.

"List of Text Books Adopted," 1890.

"District Clerk's Report," 1890-1894.

“Oaths of School Directors,” 1890-1895.

**Volume 2:** “Records of School District No. 35, Township No. 31, Range No. 10-11, County of Bolinger[sic], State of Missouri.”

“Record of Annual School Meetings,” 1915-1926. The district appears to have been known locally as “Hamstring.”

“Record of Special School Meeting,” 1927. A normal continuation of the above category.
