Historical Note:

Southwest Missouri Resource Conservation and Development (RC&D) was a non-profit volunteer-driven organization, which operated in fifteen Southwest Missouri counties. It was founded by concerned citizens from ten Southwest Missouri counties on July 7, 1968. The additional five counties would be added in 1974. It was authorized to operate under the provisions of the 1962 U.S. Department of Agriculture Act. The organization's mission was the improvement of "natural resource management and economic development through cooperative efforts."

Some of the accomplishments of the RC&D included the building of a dam in Southwest City, the development and improvement of numerous city parks, enhancements of school playgrounds and football fields to prevent erosion, fire prevention projects, water quality projects, and recently the "Trees for Joplin" campaign. All of these projects depended on the hard work of volunteers from all walks of life. "Trees for Joplin," an effort to replant trees lost in the 2011 tornado, was funded solely through the efforts of the public.

The Southwest Missouri Resource Conservation and Development operated with funds administered by the USDA Forest Service in partnership with the Missouri Department of Conservation. Each of the fifteen counties also paid sponsorship dues through their County Commissions and Soil and Water Conservation Districts. Those fifteen counties included Barry, Barton, Cedar, Christian, Dade, Dallas, Greene, Jasper, Lawrence, McDonald, Newton, Polk, Stone, Taney, and Webster. In 2011, Congress eliminated all federal funding for RC&D, preventing the Southwest Missouri RC&D from continuing its mission in the communities of Southwest Missouri.
