Jeanette Mott Oxford, member of the Missouri House of Representatives; State Representative, District 59, donated records from the Coalition Against Public Funding for Stadiums to the Western Historical Manuscript Collection-St. Louis on January 23, 2008.

The Coalition Against Public Funding For Stadiums is an organization founded by Jeannete Mott Oxford and Fred Lindecke formed in hopes of rejecting the proposed use of \$421 million in state, county, and city funds for the building of a new ballpark. Although their attempts were unsuccessful, they were able to save taxpayers at least half of this cost, as well as creating new ordinances in the city and county, which called for a public vote on any public use of funds for any professional sports development.

The collection includes Affidavits, 2005; Application of Transfers, 2006; and several other documents from both the plaintiffs and defendants viewpoint. Also includes Campaign Fundraising Documentation, 2006; as well as Lawsuit Documentation spanning from Agreements and Contributions, to Financial Information and Final Judgements, 2004-06.
