Series Description

Series 1 Nuclear Weapons Freeze Campaign, 1982-1986

Ben Senturia directed the Clearinghouse for the Nuclear Freeze campaign, headquartered in St. Louis. The Freeze campaign advocated limiting the production of nuclear weapons, and then reducing the nuclear arsenal by the United States. The campaign peaked in the mid-1980s as the administration of President Ronald Reagan sought to match the nuclear weaponry of the Soviet Union. For further information on Senturia's reform activities, see the collections listed above.

Series 1 is composed of newsletters and other publications advocating the freeze published for the groups and individuals supporting the freeze effort.

Series 2 Campaign Finance Reform, 1988-2006

An ardent advocate of campaign finance reform in Missouri, Ben Senturia worked for years to amend the state constitution by initiative petition to limit private campaign contributions in state elections. Among other efforts, he was active in the Working Group on Electoral Democracy (WGED, 1988-1994), Missouri Alliance for Campaign Reform (MACR, 1993-1998) and Missouri Voters for Fair Elections (MVFE), 1998-2000. Series 2 is composed of photographs of campaign supporters, petition forms, material for public distribution, and other items related to campaign finance reform in the 1990s and early 2000s.
